

California Law Enforcement Liaison Program







VISION — Everyone traveling on California roadways will go safely.

The California Law Enforcement Liaison (LEL) Program is managed by the Office of Traffic Safety (OTS). The LEL role is to provide technical assistance and promote partnerships with law enforcement agencies through coordination and collaboration with the OTS. The LEL serves as a bridge between the OTS and law enforcement agencies to further program goals to eliminate traffic fatalities and injuries on California roadways. The LEL encourages law enforcement leaders to support programs through education and the enforcement of traffic safety laws, with a focus on high priority areas such as impaired driving, vulnerable road users, occupant protection, distracted driving, and speed management.

Grant Funding


In partnership with the National Highway Traffic Safety Administration (NHTSA), the OTS provides grant funds to government entities to conduct effective state and local behavioral traffic safety programs.

Enforcement Projects

Selective Traffic Enforcement Program (STEP) grants provide funds to law enforcement agencies for High Visibility Enforcement Operations. These grants may include funds for the enforcement of Impaired Driving, Distracted Driving, Motorcycle Safety, Bicycle and Pedestrian, Occupant Protection, and Primary Crash Factor operations.

Law Enforcement Training

The OTS provides funding for Law Enforcement training related to traffic safety. Examples include, but are not limited to SFST, ARIDE, DRE Certification, DUI Checkpoint Planning and Management, Crash Investigation and Reconstruction, Prosecution Case Law, and much more.
